The Higher Education Act (HEA) uses the McKinney-Vento Act's definition of homeless, which includes youth who lack a fixed, regular, and adequate nighttime residence; and unaccompanied, which includes youth not in the physical custody of a parent or guardian. This definition is broader than shelters or the streets; it includes:

- Staying with others temporarily due to loss of housing, economic hardship, or similar reason
- Staying in motels due to lack of adequate alternative accommodations

The HEA uses at-risk of homelessness to refer to students whose housing may cease to be fixed, regular, and adequate.

This form is to be used to assist in determining your status as an independent student. Note: If the documentation you provide is not from an authorized entity or we need further explanation, we may ask you to submit the questions below.

- Financial aid administrator at another institution who previously made a determination
