To appeal a termination of financial aid, a student must submit proof of extenuating circumstances, beyond the student's control, that interfered with the successful completion of studies. Please note the following examples of extenuating circumstances and the appeal process.

Appeal Deadlines:

16-week and 12-week start: *Fall 2024 – August 13, 2024 *Spring 2025 – January 14, 2025 *Summer 2025 – June 6, 2025
 All late start 8-week (2nd half): *Fall 2024 – October 9, 2024 *Spring 2025 – March 12, 2025

- Provide supporting documentation. (E.g., doctor's statement, police report(s), obituary, eviction notice)
- Financial aid academic plan agreement
- Meet with an academic advisor and complete a probation contract or My Academic Plan (MAP). **(Check Banner-Self Service to determine which document is needed.)**

(Failure to provide supporting documentation will result in financial aid appeal being denied.)

Academic Plans/Contracts are required for students who are not making satisfactory academic progress in accordance with federal guidelines. Academic Plans are intended to help students regain financial aid eligibility while keeping them on a direct path to graduation. By submitting this Academic Plan/Contract with your appeal, you are agreeing to follow the plan as written and successfully complete the courses as listed.

Your plan/contract will be monitored throughout the academic year to assist in determining your eligibility for financial aid. Failure to meet the conditions of the Academic Plan will result in you being ineligible for financial aid for the next period of enrollment (semester). Students who have appeals approved are placed on financial aid probation and must follow their Academic Plan to maintain their eligibility for financial aid, until they are back in good academic standing for financial aid purposes. Students on financial aid probation cannot change their major until they are back in good standing. Students who choose to change their major will have their aid terminated as a violation of their Financial Aid Academic Plan. The committee will assess all appeals based on documentation provided, as well as academic history. Students will be notified in writing of the committee’s decision. All appeal decisions are final.
